In September, the newly composed board came together for a strategic two-day off-site session. More than just a planning exercise, it served as a moment of reflection and renewed ambition. Out of this retreat, a comprehensive strategic plan emerged—one that sets a clear and purposeful direction for the years ahead.

At the heart of this plan lies a renewed focus on our members. We launched a broad membership survey to understand the evolving needs of both members and non-members. This input will be critical in ensuring our future actions remain relevant, valuable, and responsive to the expectations of our community.

A mapping of key organizations—including Guberna, ISACA, IBR, NBB, FSMA, Febelfin, and others—has been initiated, along with outreach efforts to align our interests and objectives. These initiatives are coordinated closely with ECIIA and IIA Global, ensuring a consistent and strategic voice for internal audit on both national and international levels.

Alongside this, we are preparing to launch a mentorship program that will support the next generation of auditors and create rewarding internal opportunities for experienced professionals to give back.

Message to our members From IIA Global

As we reflect on the milestones of the past year, we are proud to share a renewed sense of global alignment, progress, and purpose for the internal audit profession. At the heart of this evolution is the release of the new Global Internal Audit Standards, effective since January 2024. These standards represent the culmination of more than three years of research and global consultation with stakeholders across 155 countries. Designed to meet the complex demands of a fast-changing world, they provide a flexible, principle-based framework that elevates both consistency and adaptability in practice. The Standards have already been downloaded over 600,000 times and are now available in 24 languages — including French and Dutch—making them immediately accessible to our members in Belgium.

At the heart of this evolution is the release of the new Global Internal Audit Standards, effective since January 2024.

One of the central pillars of our future vision is Internal Audit: Vision 2035 – Creating Our Future Together. This strategic initiative emphasizes the increasingly critical role of internal auditors as trusted advisors within their organizations, encouraging practitioners to move beyond assurance to contribute more directly to strategy, governance, and transformation. Developed with input from more than 7,000 stakeholders worldwide, Vision 2035 offers a forward-looking blueprint that aligns strongly with the ambitions and practices of European auditors, and we encourage all members of IIA Belgium to engage with it actively.

One of the central pillars of our future vision is Internal Audit: Vision 2035 - Creating Our Future Together.

In the realm of advocacy, our global team continues to support national institutes by developing frameworks that strengthen the positioning of internal audit across public and private sectors. A key achievement was the publication of the Global Public Policy Position Paper and the draft Internal Audit Model Act, which aim to provide consistent guidance for policymakers while enhancing the profession's recognition and influence worldwide. These tools are intended to support the kind of strategic outreach and institutional partnerships that IIA Belgium is actively pursuing in its own environment.

A key achievement was the publication of the Global Public Policy Position Paper and the draft Internal Audit Model Act.



On the talent front, we celebrated the awarding of over 200,000 CIA® certifications globally, underscoring the continued relevance of the designation in setting the gold standard for internal audit excellence. The updated CIA syllabus is now fully aligned with the new Standards and better reflects the global practice of internal auditing today. IIA Global is also expanding its Internal Audit Education Programs to more than 150 institutions worldwide, creating new opportunities for students across Europe to join and shape our profession.

Finally, our work to support the profession's readiness for the future has included initiatives on AI adoption, the publication of a new Quality Assessment Manual, and global coordination on strategic planning and pricing—all aimed at helping national institutes like IIA Belgium serve their members more effectively and consistently.

Together, we are part of a truly global movement — one that is elevating the value of internal audit across all sectors and regions. We thank the members of IIA Belgium for their contributions to this shared mission and encourage you to remain engaged, informed, and inspired as we shape the future of the profession together.




